Oversight of NHW

- POA Board
- POA Safety & Security Committee
 - periodic crime updates for CC
 - receive NHW suggestions for improving CC safety
- POA Disaster Preparedness Committee
 - post-disaster use of NHW assets
- North Charleston Police Dept

Past CC Problems

- Community residents have experienced thefts of property from cars, homes and a home invasion
 - Several cars unlocked
 - Arrest in 2011 has halted most theft activity
 - Home invasion not resolved
- Fences and postings at the community perimeter have not kept trespassers away.
 - Most are residents or friends not all
- Ignoring these problems may lead to family safety concerns and further theft.

NHW Concept "Neighbors Helping Neighbors"

- I. Be alert
- 2. Be safe
- 3. Be respectful & professional
- 4. Report suspicious or criminal activity to police

I. Be Alert

- We are the people most responsible for our safety and that of our families - police seldom prevent crime
- Get to know your neighbors without being nosy
- Observe the neighborhood routine in your daily activities - know the normal so the unusual & suspicious stand out
- NHW & NCPD provide training & reference materials on how to observe & report
- Be alert, observant & caring

2. Be Safe

- Observe do not confront
- Verbally interact only if you feel safe
- POA Board position that no weapons allowed as NHW representative

3. Be respectful/professional

- Get to know neighbors while respecting their privacy - everyone has different threshold of openness
- Respectfully obtain input from neighbors regarding their concerns
- Do not confront we are not vigilantes or police officers
- Offer materials to make homes, autos, streets safer from crime

4. Report suspicious/criminal activity to NCPD

- Police can use information from NHW reporting to reduce crime
- Must be willing to call police don't "pass the buck"
- Call 911 for crime or clear safety issue
- Call duty line (745-1015) when activity seems suspicious but not clearly criminal

Related aspects of NHW

- Does not have to be all of Coosaw Creek
- We can organize those areas with more interest & willingness to participate
- We can be flexible within NHW:
 - Focus on things of concern to that area
 - Be inclusive, not one size fits all areas
 - Spectrum from 'learn to be safer' to 'neighbor patrol'
- If NHW effort unsuccessful, we can choose to be more alert and report if necessary
